

## 2018 Fee Schedule — BADAS Fairground Facilities

**Training/Schooling Sessions:** Must be booked through the BADAS booking “agent” but does not require a rental agreement, except for camps. **Camps, Clinics and Schooling Sessions DO NOT** have exclusive use of the Fairground facilities unless negotiated with and agreed to by BADAS (possibly with additional fees).

**Events: MUST** be booked in advance through a **rental agreement** and approved by BADAS. Exclusive use of the rented facility(ies) is an option that can be negotiated with a rental agreement.

Additional Notes – If one or more days are required to set-up a competition course prior to the event, BADAS should be compensated accordingly since the facility(ies) are not available for rent to others. Compensation is negotiable.

<sup>†</sup>**Public Riding:** Available, with a booking, only when facilities are not busy (check bookings on “Events/Booking Calendar” under “Facilities & Bookings” at [www.beaumontagsociety.com](http://www.beaumontagsociety.com)). <sup>1</sup>Hack riders can ride the area around the X-Country Course **without using any jumps**. Anyone using a X-Country jump **MUST** have a qualified coach/instructor with them.

<sup>‡</sup>**Stabling, Outdoor:** 94 open air stalls (1 full-sized horse per stall please) are available. These stalls were NOT built for overnight use, and are therefore rented on a daily basis only. Gate closures for each stall are **not** provided by BADAS.

<sup>§</sup>**Stabling, Covered:** BADAS opened a 30-stall pole barn in 2010. Water for equine use is collected from the roof via a gutter system and collected in large tanks located at either end of the building. Shavings are **not** provided by BADAS.

**\*Stabling Deposit:** \$40 deposit (separate cheque) required for each covered stall to ensure that it is properly stripped to bare earth after use. Deposit cheques will be returned or destroyed after stalls have been checked for proper cleaning.

<sup>€</sup>**Garden Plot:** Fees listed above are for BADAS members (see [www.beaumontagsociety.com](http://www.beaumontagsociety.com) for a link to an online membership registration system), and provide either a half-sized (about 300 ft<sup>2</sup>) or full-sized (roughly 600 ft<sup>2</sup>) plot for the growing season (approximately May 1 to September 30). **Membership is now required.**

## Booking, Sign-In, Waiver and Payment Instructions

**Bookings:** All riders, including those with Season Passes, must make bookings in order to have permission to use the BADAS facilities. To see availability of BADAS Fairground facilities, check the **Events/Booking Calendar** under “Facilities & Bookings” on the BADAS web site – [www.beaumontagsociety.com](http://www.beaumontagsociety.com). On the same web page, just below Booking Calendar link, click on the **BADAS Booking Procedure & Form** link. Please read carefully as this document provides instructions on making a booking. Fill in the information required on page 2 of the Booking Form, and email a scanned copy to [bookings@beaumontagsociety.com](mailto:bookings@beaumontagsociety.com). The BADAS General Manager, Bruce Walker (mobile 780-983-7525), or Alternate Booking Agent, Amberly Billings (mobile 780-984-2009), can be contacted if you need help with the booking.

A **rental agreement must be in place** for all event and multi-day (e.g. camp) bookings. Short camps (e.g. 1- or 2-day camps) have the option of entering into a rental agreement with BADAS or making a booking for x number of riders. If more than 12 participants are expected during a 1-day event, a rental agreement offers lower cost per rider. To initiate a rental agreement, send a scanned copy of your completed and signed booking form to [bookings@beaumontagsociety.com](mailto:bookings@beaumontagsociety.com). The General Manager or Alternate Booking Agent will prepare a rental agreement based on the information that you send in, sign it in the appropriate places, and return it to you via email for your signature. A deposit (usually half of the facility fee) is required to confirm the rental booking.

**Equine Use Waiver/General Use Waiver forms:** All equine facility users **MUST** fill in and sign an **Equine Use Waiver form** for 2018 before their first use of the Fairground facilities. Gardeners, volunteers, and other non-equine users will complete and sign a General Use Waiver form at the beginning of the season when they sign up for their activities. Both forms are available online – [www.beaumontagsociety.com](http://www.beaumontagsociety.com) on the “Facilities and Bookings” page. Blank Equine Use Waiver forms will also be available on-site in a drop-box located at the **Sign-In Station** located on the old Office/Concession Trailer.

**IMPORTANT NOTE 1:** Riders will **NOT** be allowed to use the facilities without current (active) AEF or equivalent insurance coverage. AEF numbers **MUST** be printed on the Equine Use Waiver form.

**Sign-In Sheets:** Every user group using one or more of the BADAS Fairground facilities **must sign in** for EACH riding session. Exceptions to this requirement are gardeners. The **Sign-In Station** is located on the west-facing wall of the old Office/Concession Trailer parked in the paddock area. Waiver forms will also be available here.

**Payment:** Payment can be made by cheque, e-Transfer or cash **{absolutely no coins}**. Cheques and cash can be left in the drop-box (attached to the Sign-In board). **Cheque is the preferred method of payment** – make sure they are properly dated and made out to one of:

- **Beaumont & District Agricultural Society** OR **Beaumont & District Ag Society**
- **Beaumont Ag Society** OR **BADAS** are also accepted by the bank; **other wording is NOT accepted.**

**Payment by e-Transfer** – Make sure that you are setup with your bank for e-Transfer capability. Also, set up a security question and response beforehand with the BADAS Booking Agent. With these arrangements in place, **transfer funds to [bookings@beaumontagsociety.com](mailto:bookings@beaumontagsociety.com)**. In the comment/note section of the e-Transfer, include a brief statement about what the payment covers, including date of the ride.

**IMPORTANT NOTE 2:** Any equestrian activities involving jumping are to be undertaken with more than one person present (i.e. NO lone riders) for safety purposes. **Cross-Country Course riders MUST have a qualified instructor with them at all times.** In the instance of the mounted instructor schooling jumps, there must be a responsible person, mounted or un-mounted, over the age of 18 accompanying them. It is preferable to have someone carry a cell phone in case of an emergency.
